Description: The APX 5.0-30.0P- S2 high-voltage battery system consists of two parts; The first part is the APX 5.0P-B1 battery system; The internal energy storage unit includes an electrochemical battery, DC/DC high-frequency isolation boost circuit, communication circuit, etc., a battery management system (BMS), power and signal terminals, and mechanical components. Each APX 5.0P-B1 consists of a 100Ah battery.

The second part is the high-voltage box: APX 98034-P2; The APX98034-P2 can generate 15KW power through software control. The high-voltage box is composed of a control circuit, a DC/DC voltage rise and fall circuit, a sampling circuit, and a communication circuit inside; High-voltage boxes and the APX 5.0P-B1 battery system form 6 different models.


